2020 Report on Recruitment Measures for Disadvantaged Students and Achievements

1. Method :

National Changhua University of Education has provided the following opportunities for disadvantaged students (including indigenous students, financially disadvantaged students, and disabled students):

- (1) Encouraging departments to provide extra quotas to allow disadvantaged students to enrol in university programmes
 - 1. Our University has been actively providing extra quotas to allow indigenous and disabled students to enrol and study at the University through various channels.
 - 2. Our University has made considerations for disadvantaged students by lowering the admission threshold for "Individual Applications" in the 2018 academic year, giving priority admissions to several disadvantaged students.
 - 3. Our University has added a Yang Ying admissions group to the "Individual Applications" since the 2019 academic year that is limited to financially disadvantaged students, providing lower selection criteria and simpler screening processes to increase such students' chances of admission.
 - 4. In order to encourage departments to actively provide additional quotas for disadvantaged students, our university's "Measures for Establishment and Promotion of the Admission Strategy Committee" stipulates that the actual total registered number of additional quota (including overseas students, students with disabilities, and indigenous students) of various programmes in a department in the current academic year will be multiplied by NTD 5,000 in additional department affair expenses.
- (2) Reducing the financial burden of application for disadvantaged students no application fee charge and subsidizing travel and accommodation fees
 - 1.Our University does not charge an application fee for financially disadvantaged students (those from low-income households and middle-to-low-income households) who participate in the University's admissions exam: "Second Stage of the Individual Application for Undergraduate Program", "Transfer Exam for Undergraduate Program", "Recommended and Admissions Examination for Master's Program", and "Independent Admissions of Disabled Students in Undergraduate Programs".
 - 2. In the second stage of screening for "Individual Applications" and "Admissions into Four-Year Technological Undergraduate and Two-Year Vocational Junior College Programs", our university will subsidize travel and accommodation fees for eligible students on their exam day through their respective departments.
