I. Policy:

NCUE offers several education opportunities for disadvantaged students (e.g. aboriginals, students with physical and/or mental health conditions, economically disadvantaged students):

- 1) It encourages faculties to recruit disadvantaged students and increase their chances of receiving offers.
 - 1. In recent years, the university has been actively providing additional places for aboriginal students and students with physical and/or mental health conditions through various channels.
 - 2. To provide comprehensive care for disadvantaged students, the university has relaxed admission requirements for 'individual applicants' since the 107th academic year, providing priority offers to several economically disadvantaged students.
 - 3. Since the 108th academic year, the university has included a 'Yang-Ying' admission scheme in its individual applications. The scheme is only available to economically disadvantaged applicants. The threshold test score and entry requirements are adjusted, and the selection process is simplified to increase their chances of receiving offers.
 - 4. To encourage departments to recruit students from disadvantaged backgrounds, the university's Admissions Strategy Committee will compensate each department or faculty by NT\$5000 for each additional place offered to foreign students, aboriginal students, or students with physical and/or mental health conditions in the current academic year. The compensation covers the additional operating fee to promote departmental recruitment.
- It supports disadvantaged students by waiving application fees and subsidising 'individual application' travel and accommodation expenses
 - 1. Students from economically disadvantaged backgrounds (low-income and lower-middle-income households) are exempted from the application fee for our self-administered entrance examinations: the Individual Application Stage 2 Examination for a Bachelor's Degree, the Transfer Examination for a Bachelor's Degree, the Recommendation Examination and Admission Examination for a Master's Degree, and the

Individual Admission Examination for a Bachelor's Degree for Students with Physical or Mental Health Conditions.

2. The university will subsidise the transportation and accommodation costs for students taking the Stage 2 Individual Application Exam and the TCTE exam depending on their place of residence. Each faculty will be asked to send the subsidy to the eligible candidates on the day of the examination.
