The university provides various forms of financial assistance or subsidies to students from developing countries

The university subsidises students from developing countries by means of grants and scholarships. Epidemic prevention subsidies, as well as reduction or exemption of tuition and miscellaneous expenses, are also provided by the government, university, or agencies outside the university. Examples are as follows:

- 1. Government grants
- (1) Taiwan Scholarship of the Ministry of Education: University winners receive a scholarship with a monthly living stipend of NT \$15,000 for up to four years, and a subsidy of NT \$40,000 per semester. The award-winning students at the institute will receive a scholarship for monthly living expenses of NT \$20,000 for up to two years and a subsidy of NT \$40,000 per semester.
- (2) Grants of the Ministry of Education for needy overseas Chinese students: The recipients of the grant will receive NT \$3,000 per month for up to 12 months.
- (3) Scholarship for outstanding overseas Chinese students of the Ministry of Education: The winner will receive NT \$10,000 per month for six months.
- (4) Overseas Community Affairs Council scholarship
- (5) Overseas Community Affairs Council study assistance fund
- (6) The Overseas Community Affairs Council accepts donations for awards and grants for overseas Chinese students.
- (7) Excellent academic performance award of the Overseas Community Affairs Council for Chinese students for graduating from overseas colleges and universities.
- (8) Chairman scholarship of the Overseas Community Affairs Council for outstanding Chinese students who graduated overseas.
- (9) The Overseas Community Affairs Council provides assistance for Chinese students' medical emergency and funeral condolences.
- (10) Taiwan Experience Education Program (TEEP)
- (11) Research projects of the Ministry of Education and the Ministry of Science and Technology

- 2. Scholarships and preferential measures provided by the school
- (1) Reduction and exemption of tuition and miscellaneous fees for the university's overseas community: Those who are eligible will get an exemption from, or reduction by, 1/3 of the tuition and miscellaneous fees in the autumn and spring semesters, with a total reduction of NT \$627,096 per year.
- (2) Key points for the implementation of the school's award to foreign students: The winners are exempt from tuition and miscellaneous fees and accommodation fees for one academic year.
- (3) Instalment payment of tuition and miscellaneous expenses: Overseas community and foreign students with a low-income family certificate may apply to the Office of Student Affairs for instalment payment of tuition and miscellaneous expenses, which can be paid in three instalments at most.
- (4) Scholarship for outstanding students: Including scholarships for excellence, outstanding talents, and service.
- (5) Work–study grants for students: Including students with physical and mental disabilities; aboriginal students; those who meet the qualification requirements of the financial aid program for vulnerable students in colleges and universities (low-income households, mid-to-low-income households, children with special situations, and children of people with physical and mental disabilities); students affected by economic difficulties caused by family changes, and overseas community and international students with low-income certificates.
- (6) Postgraduate grants
- 3. Scholarships provided outside the school
- (1) Dr Yeoh Tiong Lay Diligent Scholarship and Admission Scholarship of Malaysia: A total of six recipients are approved for the scholarship and issued NT \$5,000 per month and NT \$360,000 per year.
- (2) The university's industry–university cooperation projects with government agencies, institutions, non-governmental organisations, and academic research institutions.
- 4. Covid-19 epidemic-related subsidies

- (1) Epidemic prevention subsidy for overseas community and international students in the 110th academic year of the university: Each overseas community and international student arriving in Taiwan receives a single transportation subsidy from the airport to the quarantine hotel, between NT \$1,000 and NT \$2,660.
- (2) Epidemic prevention compensation of the Ministry of Health and Welfare: NT \$1,000 per day during the quarantine period, and NT \$15,000 at most.
- (3) Subsidy for epidemic prevention accommodation of overseas community and international freshmen of the Overseas Community Affairs Council in the university's 110th academic year: The subsidy for overseas community and international freshmen is NT \$5,000.
